MEETING MINUTES

PRELIMINARY MATTERS

Mr. Perry Pander, Board Vice President, called the meeting to order at 7:34PM. Following the Pledge of Allegiance, Mrs. Helsing announced that the PLRB's decision on the Teacher's Contract has been received. The PLRB Board ruled in favor of the Blackhawk Education Association. Mrs. Helsing also stated that the Blackhawk Board of Directors will honor this decision.

Mrs. Kaszer advised that in an effort to conserve costs and respect the environment, we will not be using paper agendas in the future. The agenda will be posted on the website. Mr. Pander noted that there was an executive session for personnel matters prior to the Voting Session.

PUBLIC RELATIONS AND COMMUNICATIONS

Mrs. Lyndsay Wilcox, Vo-Ag instructor, Mr. Boyers, Assistant Principal, and the Vo-Ag students provided a presentation on their activities this school year and anticipated activities/classes for the coming years. Highlights included:

- Breaking the school's Vo-Ag sausage making/sale
- Recent competition in Harrisburg, including awards received
- New subject being added to next year's curriculum
- Number of Vo-Ag Students by classes offered

Mr. Fleishman congratulated Jeff Tripodi, high school gifted teacher, for being this year's recipient of the Roy A. Hunt Foundation Award for Commitment to Education in the Arts and Humanities for 2015. This award is given annually to one Pittsburgh-area teacher who demonstrates excellence in incorporating the arts into his student's learning experience.

Mr. Fleishman extended congratulations to Jack Whalen, he earned first chair at Regional Band this past weekend, and will be attending the All-State Festival at the end of March in Hershey.

Mr. Fleishman offered commendations to Noah Schiemer, Haley Brightwell, Noelle Hughes, Jack Whalen, Michelle Myers and Aleena Milinski who qualified and performed in the District 2, 3, 5 Orchestra Festival on February 6th at Hickory High School in Hermitage, PA. As a result of their chair auditions at District 2, 3, 5 Orchestra Festival, the following students were chosen for Regional Orchestra (the eastern half of Pennsylvania) to be held March 12-15 in Erie, Pennsylvania: Noelle Hughes, Noah Schiemer, Aleena Milinski, and Jack Whalen.

Mr. Fleishman extended congratulations to Mariah Aquino, third grade student. Mariah received a Great Lakes Region Travel Award to attend the 2015 Advocacy Summit in Washington, DC, in March. Mariah and her family will be visiting Capitol Hill to represent the more than 50 million Americans living with arthritis. Mr. Fleishman acknowledged that Mariah's mother is Blackhawk School Director, Ms. Aquino.

Condolences to the Raab family was extended by Mr. Fleishman. Former Blackhawk High School Teacher, Harry Raab, passed away February 1, 2015. Mr. Fleishman provided some reflection on Mr. Raab's service to the school district.

Mr. Yonkee extended condolences to the McCarter Family; Jon McCarter passed away Wednesday, February 20th. The arrangements are set for this weekend. Mr. Yonkee acknowledged Jon as a longtime friend and partner with the district for over 40 years.

PUBLIC COMMENT

Mr. Jarred McCowin, Chippewa, thanked the board for honoring the contract and thanked the community for standing behind the teachers and the teachers for their professionalism.

Mr. Bob Clendennen, Patterson Township, spoke on several issues:

- Noted that he received the meeting documentation through a 'Right-to-Know' request and thanked the board.
- Glad that the teachers' contract issue is done and ruling did not represent a 'lame duck' situation.
- Addressed the lack of documentation on Mr. Weiss' contract.
- Discussed finances including the \$250,000 transfer to the construction fund.

Mr. Frombach provided a response regarding the finances. There was a reference to \$250,000 in the 2013-14 budget, as of the end of June it was not transferred. However, there is a note of transfer for this year too. As for the difference in the local tax, there is \$985 that should not be in the real estate taxes. This is money is received from the state. It is showing in both the real estate and state revenues. The \$300,000 received from the federal government for cafeteria/milk expenses needs to be kept separate.

Mr. Yonkee noted that the Monthly Insurance Report for January was provided as an Informational Item.

A motion was made by Mr. Yonkee to appoint Pam Kromka as Blackhawk School District authorized representative to make request upon and receive any and all tax information and records from Berkheimer, relative to the collection of taxes for official purposes only. (Mr. John Frombach is also an authorized requestor per January 2015 Board approval.) This motion was seconded by Mr. Fleishman.

Mr. Yonkee made a motion to contract with NaviGate for security systems in each school building at no cost. This motion was seconded by Mrs. Kaszer. Mr. Pander provided a brief summary of NaviGate for those that may have missed the presentation at a prior meeting.

A motion to increase the Right To Know, Open Records Fees was made by Mr. Yonkee and seconded by Mrs. Kaszer. It was noted that the new fee will be 25 cents per page.

Mr. Yonkee made a motion to authorized the Administration to work with Public Financial Management, (PFM), as Financial Advisor, Dinsmore & Shohl LLP as Bond counsel, an Underwriter to be named and the local Solicitor in conjunction with issuance of the General Obligation Bonds, Series of 2015, for the purpose of advance refunding the School District's General Obligation Bonds, Series of 2012 with a minimum net savings target of \$271,000. This motion was seconded by Mr. Young. Mr. Frombach noted that at this time, PFM will be acting as a financial advisor. PFM will also be reviewing the districts Trane account for possible refinancing. Mrs. Kaszer noted that in order to refund the Series 2012 bonds, a bond rating of A2 is required. She then inquired about the District's current rating. Mr. Frombach advised that would be determined during the process. Mr. Yonkee inquired if there was any duplication of efforts / costs and Mr. Frombach advised that there is not.
