#### **Highland Middle School Renovation Project**

OCIP- Owner's Controlled Insurance Program presented by Jerry Wessel

- Once the Board commits to OCIP, the bid documents and contracts will be written with this language. A change in the Board's decision after this may cost time and money on the project.
- Board motion: \*6.1 Approval is recommended to utilize Owner's Controlled Insurance Program (OCIP) for the Highland Renovation Project.
- Mr. Wessel commented that because students will remain in the building, safety is a priority. OCIP has a first rate safety program
- Dr. Miller expressed concern that if the Board changed their decision after approving OCIP, there would be time and cost factors associated with such a decision.
- Mr. Wessel commented that Jack Bonus stated that the rates were unbeatable. PSBA has specialized in this area and this is reflected in the rates.

Door installation at BHS

- Change order

- Mrs. Pander asked Tom Durkin to review the door hardware because some people have trouble
  opening the doors. Mr. Durkin stated that he would review it and that an adjustment to the
  closure would be needed.

#### PPS kitchen

- A Board motion will be placed on a February 17 addendum authorizing VEBH to proceed.
- Meeting to be held on Monday, February 14 for final review of equipment and kitchen needs.

- Timeframe Bids in April, work 16 weeks in summer, Award contracts May 12
- Discussed pre-ordering equipment.
- Mr. Fleischman suggested that Mr. Wessel join the meeting because of his expertise.
- The tentative budget for this project is \$324,000.

#### ADA – District Accessibility

- A Board motion will be placed on a February 17 addendum authorizing VEBH to proceed.
- VEBH will complete a needs assessment and possible solution to propose to the Board in the following areas:
  - a. PPS restrooms and solution for access between first and second floor (elevator, lift, etc...)
  - b. BHS select restrooms and solution for access to locker rooms/pool from 1<sup>st</sup> floor and upgrade to current elevator
  - c. Northwestern review restrooms (we have 1 handicapped restroom) and address access to stadium/seating
  - d. Mr. Durkin reported that accessibility will be appropriate at BIS and HMS after renovation or pavement projects are completed.

## **NW Windows**

- A Board motion will be placed on a February 17 addendum authorizing VEBH to proceed.
- Review with Board and determine desire to place this item on the February 17 agenda (addendum).
- If approved for VEBH to continue on February 17, consider Fall 2011 or Summer 2012 construction due to the number of projects clerk of the works/district representative will have to oversee (PPS kitchen, BIS pavement, BHS pavement, HMS project)

Stadium - Turf - Sewage - Water at NW

- Need to identify long-term plan before making these decisions
