**Superintendent's Report:**

Over the last weeks, the Administration has been reviewing the data from the PA Department of Health, the statistics from the Centers for Disease Control (CDC), and the guidelines on the PA Department of Education (PDE) resource page, "Determining Instructional Models During the COVID-19 Pandemic".

Based upon the most recent analysis of available data and consultation with the District Solicitor, I have concluded that in-person instruction in the District poses a threat and danger to the health and welfare of the students, staff, and community. In addition, an in-person instruction model would create staffing challenges and could expose the District to potential liability, given the data presented and the issues surrounding liability coverage.

By the authority granted to me under Section 520.1 of the PA School Code and the resolution approved by the Board on July 16, 2020, I am authorizing instruction to begin on September 8, 2020, with a full remote (virtual) model as presented to the Board for a minimum period of four weeks, which could be extended should there

continue to be a substantial threat to the health and welfare of the students, staff, and community. Section 520.1 and the resolution approved by the Board will allow the instruction time spent remotely to count towards the minimum instruction requirements of the School Code being 180 days, 900 hours /990 hours.

The District will continue to implement its Health and Safety Plan with a transition to the hybrid model when an analysis of the data supports a safe return to this model. It is and continues to be our hope that in the future we can provide, as much as possible, live in-person instruction through a face-to-face model.
