Wonders is a comprehensive literacy program that addresses all aspects of learning to read including phonics, comprehension, writing and grammar. It includes a comprehensive digital component that allows students to work from home if necessary. There are multiple features of the program to address readers at all levels. As part of our purchase, the district is receiving \$25,000 worth of leveled reading books for free. This new series replaces StoryTown, which was purchased in 2008.
