6. BUILDINGS AND GROUNDS/REAL ESTATE Bob Clendennen, Chairperson

- *6.1 Approval is recommended to authorize VEBH to complete bidding documents for Option A (addition of ramp and ADA accessible seating that will replace several rows of bleachers) as presented on October 20, 2011 by VEBH for the Northwestern Stadium to address ADA access to the football stands.
- 6.2 Approval is recommended to acknowledge receipt of Plan Con G for the Highland Middle School Renovation Project. (Exhibit D)

- Approval is recommended to approve a change order to McElroy Paving in the amount of \$17,677 for earthwork related to stabilize and restore the existing slope along the Dillon Street side of the High School athletic field as required by the Beaver County Conservation District. The limits of the work required to stabilize the slope and being approved by this motion are as approved by the Beaver County Conservation District and exceed the estimated limits of work included in the value of the previously "not to exceed" cost. Therefore, this motion rescinds the previous "not to exceed" motion as approved at the October 20, 2011 Board Meeting. (Exhibit E)
- Informational Item: Topsoil and lawn seeding on the outfield of the high school athletic field. The Board approved a "not to exceed" motion at the October 20, 2011 Board meeting. McElroy Paving provided a verbal estimate of \$5,000 before drawings were approved by the Beaver County Conservation District. After reviewing the drawings, McElroy has quoted the work in the amount of \$19,090. The Beaver County Conservation District and DEP's first priority was the grading of the hillside. Because the work would be scheduled to be completed in the spring 2012 planting season, a review in the spring and possible bidding from other contractors may be necessary. (Exhibit E)
- Approval is recommended to approve a change order to Yarborough Development, Inc. In the amount of \$423.40 to provide a concrete slab on grade in the plumbing chase of the renovated Restroom A111. The concealed chase was exposed in the course of the work and discovered not to have a concrete floor, which is required for support of plumbing fixtures. (Exhibit F)
- Approval is recommended to approve a change order to Shipley Brothers Construction, Inc. in the amount of \$3,236.10 to provide plumbing rough-in to the washer in the Life Skills Classroom. The work was not shown on the plumbing drawings but is required for the educational program. (Exhibit G)
- 6.7 Approval is recommended to approve a change order to Shipley Brothers Construction, Inc. in the amount of \$2,959.67 to provide additional work related to underground sanitary piping at two sinks in the Art Room A117 and the one sink piped through Room A101.1 The additional piping is required in order to connect new piping to the existing piping at a point where it is of adequate size and depth. The point of connection shown on the drawings was a concealed condition that was not discovered until it was exposed in the course of construction and determined that it was not installed in the size and elevation indicated on the original construction record drawings and found to be inadequate at these three locations. (Exhibit H)
- 6.8 Approval is recommended to approve a change order to American Contracting Enterprises, Inc. in the amount of \$8,830.00 to provide asbestos abatement related to the demolition and removal of the boiler from the ground floor of the Annex. The asbestos was discovered in the concealed portion of the boiler's joints which were exposed in the course of the work. (Exhibit I)
